

# Circle 100 Donates New Bus to Billings Clinic Broadwater

At their annual fall gathering on Friday, Circle 100 members and long-term care residents gathered in the dining room of Billings Clinic Broadwater to celebrate their new bus. According to hospital CEO Justin Tiffany, the newly renovated 16-passenger bus has a lift for loading residents in their wheelchairs. The bus, purchased from Big Horn County, cost \$7,500 plus some renovation, he said. He thanked the group for raising funds to pay for the important transportation. Residents rely on the bus to transport them to doctors' appointments and for shopping.

Sherry Scofield explained the history of Circle 100 to the twenty people who attended the reception. She said the charitable group formed when the hospital and nursing home shut down in 2012. "My mother was in the nursing home when it was closed. She had to be moved to another facility. She passed away shortly after the move. It is a cause close to my heart

because of my own family's loss during that time," Another former Townsend resident, Charleen Adams Haines suggested to Sherry to start the Circle 100 as her community in Enterprise, Oregon had raised money that way. "So we started with no money but lots of love," Sherry laughed. Tiffany enumerated other needs the hospital needs such as new tables for the dining room, a dishwasher

and new patio furniture. "What we need most though is volunteers to help with long-term residents' entertainment and care," he said. Circle 100 meets once a year after soliciting \$100 each from its members. The chairwomen emphasized the group operates without meetings or activities. The hospital currently has 11 residents in its long-term care unit, Tiffany said.

## Food Pantry Works to Move Back to Original Store

Broadwater Food Pantry members are working hard to get back into their store at 315 Broadway. They were forced to move down the street to 321 Broadway when the building they occupied was seriously flooded. According to board Chairman Daryl Blumhagen, they are working with building owner Jerney Wegner to completely renovate the inside of the building after a late May flooding caused a pipe from an unoccupied upstairs apartment to break. Wegner replaced the roof of the building as well. However, he has had issues with continuing leaks. Food Pantry members were able to rent another location just down the street until renovations could be completed. Blumhagen did not give any estimate on when the repair work would be finished. "Jeremy is doing most of the work himself so it is a slow process. He also must hire the electrical and plumbing work done too so getting back into the building is going to take awhile," he explained. The Food Pantry has continued to serve its clients the first and third Saturdays of each month throughout the summer. Church members from the community volunteer on Saturdays to help clients pick up their groceries for the week. This week two volunteers from the Methodist church helped so board members jumped in to help also. According to new board member, Paula Van Haudt numbers of people needing food has been

ticking up, so the pantry needs more volunteers to work. Van Haudt talked about renovation work at the original store, while she was helping move out furniture. To a golfer, Pine Meadows Golf Course in Lewistown would be considered a rolling terrain, but to a cross-country runner, it would be deemed just plain hilly! Arguably one of the more difficult courses at the high school level, the Bulldogs were certainly challenged on Friday, September 20th along with 30 other teams. The entire roster has been affected by illness or injury the last couple of weeks, but that didn’t stop them from battling this week.

First up on the beast of a course were the Junior Varsity Boys. Sam Flesch clocked a time of 23:31 to come in 34th, while Keaton Cavasos was close behind at 24:15 to place 41st. Rounding out the JV boys were: Ross MacDonald (26:36) in 58th and Alex Johnson (27:32) in 63rd. The Junior Varsity Girls were next with a field of 79 competitors. Fiona Nelson (38:49) placed 74th, taking almost three minutes from her season’s best time.

The Varsity Boys’ gun blew at high noon with junior Nolan Flynn leading the way in 16th out of 112 runners with a time of 18:36. Sophomore Luke Tullos (22:14) and junior Patrick Gossard (22:51) in 83rd and 93rd, respectively, rounded out the men’s team.

Gavin Green and Rylan Hoveland did not race due to illness and injury.

Completing the day for the Bulldogs were the Varsity Girls with sophomore Kyla Meissner crossing the finish line in 20:30, coming in 5th. Freshman Elaine MacDonald was not far behind in 13th place in 21:16, which is her personal best time in her young career. Sophomore Arabella McDaniel (26:26) has been super consistent this season with all her times within 25 seconds of each other placing her in 79th. Fellow sophomore Shalyn Sentinella started in her first Varsity race, coming in 85th with her PR of 26:55. Senior Kaelyn Sangray was unable to finish due to illness.

Coming up Saturday, September 28th will be the Mountain West Classic in Missoula featuring over 80 schools from all of Montana’s classes as well as schools from Idaho and Washington. It is a difficult course with a decent amount of incline and easily the largest high school cross country meet of the year, aside from the state competition.

The following week will be the Headwaters Invitational in Three Forks on Friday morning, October 4th at the Headwaters Golf Course.

That will be homecoming week, so come cheer your Bulldogs!

On Friday, September 20th the Townsend Bulldogs traveled to Whitehall to take on the Trojans on their homecoming night. Coming into the game Townsend was 1-1 and Whitehall was 0-3 looking for their first win of the season.

Townsend got the scoring started off in the first quarter with a running touchdown by Tavyn Anderson. Whitehall answered back with an 80-yard touchdown pass and run. The Bulldogs came right back with a passing touchdown from Tavyn Anderson to Deegan Mattson to end the first quarter 14-7 Bulldogs.

The second quarter started off hot with an Eric Humphries forced fumble and a Bulldogs recovery. Townsend finished off the scoring drive with a Sawyer Horne rushing touchdown to bring the score to 21-7 Bulldogs. Later in the quarter Tavyn Anderson picked off the Whitehall quarterback to return the ball to the Bulldogs with momentum on their side. That momentum carried them into a Bradan Martin rushing touchdown to bring the score to 28-7 which is where the score stood at the half.

The third quarter started off strong with a long run by Tavyn Anderson to drive the Bulldogs down the field. Deegan Mattson scored on a 6-yard rushing touchdown to keep the scoring going in the third quarter. Townsend recovered a fumble which led to one of the most exciting, missed field goals you will see. Logan Johnson has one of the most powerful kicking legs in the conference and just missed from about 50 yards out. He did however go 6-7 on extra points for the day. The third quarter ended with the Bulldogs up big 35-7.

The fourth quarter was a continuation of Bulldog domination with a Tavyn Anderson passing touchdown to Deegan Mattson. Cael Sell had a sack in the quarter to bring his sack total to 5.5 on the year. The Trojans finally woke up and had a touchdown pass in the middle of the fourth, but the Bulldogs answered back with a kick return touchdown by Deegan Mattson. Deegan Mattson had himself a game with four total touchdowns and an interception on defense. The final score was a resounding Bulldog victory 48-13.

The Bulldogs next game will be a 5B matchup vs the last years state runner up Manhattan Tigers. The Tigers go into the game 3-0 while the Bulldogs are hoping to give them their first loss of the season. The game will be in Manhattan on Friday, September 27th with kickoff at 7 pm. Go Dawgs!!

Children are the light and future of the Native culture.

During the first day of the annual celebration, Native dancers and drummers gather at the Lewis and Clark County Fairgrounds from 10 AM until noon to provide Native dancing, drumming and cultural exhibitions specifically designed for local elementary school children. The dancers and drummers always make “Demonstration Day” meaningful, fun, and educational for our area youth as we celebrate Native American Awareness Week.

Beginning Friday evening at 6:00 pm, the Last Chance Community Pow Wow celebration officially kicks off when the dancers enter the arena during Grand Entry. Grand Entry is a colorful display of young and old dressed in traditional regalia, dancing to the “heartbeat” of the drum. Grand Entry is a must see! ## Baiting and Feeding Deer and Other Game Animals in Montana is Illegal

### Fish, Wildlife and Parks



Though bait products are available, they cannot be used for hunting. Montana Fish, Wildlife & Parks game wardens want to remind hunters and homeowners that baiting deer and other game animals for hunting purposes and/or purposely feeding game animals in Montana is illegal.

Many sporting goods stores in Montana offer feed, supplements, and other baiting attractants that are targeted to these various game animals. Although it is legal for vendors to sell these attractants, it is not legal for Montanans to use them for hunting purposes.

*Below is the official language in the Montana deer, elk, and antelope hunting regulations:*

\* It is unlawful for anyone to hunt or attempt to hunt any game animal or game bird by the aid of or with the use of any bait, salt lick, trap, snare, or set gun. \* Baiting shall mean the placing, exposing, depositing, distributing, or scattering of food sources or salt so as to constitute a lure or attraction. \* Artificial scents may be used to attract game animals (except black bears) and game birds.

*In addition, according to Montana Code Annotated (MCA) 87-6-216, a person may not provide supplemental feed attractants to game animals or wild turkeys by:*

\* purposely or knowingly attracting any cloven-hoofed ungulates, bears, mountain lions, or wild turkeys with supplemental feed attractants. \* after having received a previous warning, negligently failing to properly store supplemental feed attractants, and allowing any cloven-hoofed ungulates, bears, mountain lions, or wild turkeys access to the supplemental feed attractants. \* purposely or knowingly providing supplemental feed attractants in a manner that results in an artificial concentration of game animals or wild turkeys that may potentially contribute to the transmission of disease or that constitutes a threat to public safety.

*These restrictions of feeding and baiting game animals are not intended to prohibit other activities such as:*

\* the normal feeding of livestock  
\* a normal agricultural practice  
\* cultivation of a lawn or garden  
\* the commercial processing of garbage  
\* recreational feeding of birds unless, after having received a previous warning from FWP, the person continues to feed birds in a manner that attracts ungulates, bears, or wild turkeys and that may contribute to the transmission of disease or constitute a threat to public safety.

## Grill Season Will Soon be Gone with the Wind

Teriyaki is a very effective tenderizing marinade when you want to quick-cook meats. And the wasabi—Japanese horseradish—is a bonus. Wasabi is sold in both powder and paste forms. The paste is ready to use; the powder must be mixed with water and is traditionally rolled into a ball for serving. Depending on ambient humidity, you may need to adjust the water-to-powder ratio. But if you can roll it into a ball easily, the wasabi is ready to eat. (Wash hands carefully after handling it. You’ll regret getting any in your eyes.)

This recipe also works well with Ruffed, Franklin and Blue grouse. And the sherry? Townsend Drug has some on hand, and Cooks Illustrated has pointed out that, for cooking, cost doesn’t make any difference with sherry.

FYI: Since the raw pheasant has spent the night with the marinade, cooking the marinade is a necessary step here to keep everyone healthy and happy.

### Teriyaki Kabobs with Wasabi Dip

Serves 4

#### Ingredients

for the marinade

- 1/4 cup oil
- 3/8 cup lite soy sauce
- 2 tablespoons brown sugar
- 1/4 teaspoon garlic powder
- 1 tablespoon medium dry sherry
- 3/4 teaspoon ground ginger

for cooking

- breast of one pheasant, cut in 3/4 inch strips
- 4 wooden skewers
- 1 tablespoon corn starch
- 4 teaspoons wasabi powder
- 3 teaspoons cold water

#### Preparation

1. The night before: In a resealable bag, combine the oil, soy sauce, brown sugar, garlic powder, sherry, and ginger. Rinse and dry the pheasant breast strips and add to the marinade bag. Shake to coat the meat. Marinate in the refrigerator for 24 hours.
2. Thirty minutes before cooking: Cover the wooden skewers with cold water, and let soak about 30 minutes. This will keep them from burning on the grill.

#### Cooking

1. Preheat the grill to medium-high heat (about 450-500F). Drain the marinade off into a small saucepan. (You should have about 3/4 cup of marinade.) Add the corn starch to the marinade and stir well. Once the corn starch has dissolved, cook over medium heat, stirring constantly, until the marinade comes to a boil and thickens. Remove from heat and set aside.
2. Thread the pheasant strips onto the skewers adding powder or water as needed to roll easily.
3. Place the skewers on the grill, cooking about 3 minutes a side. Remove and serve with a small amount of wasabi. My favorite side dish with these skewers is grilled acorn squash: slice the squash about 1/4-inch thin, microwave until semi-soft (about 1 1/2 minutes on high/700 watts). Then, put them on the grill with the skewers, until they get nicely browned, brushing them with the cooked marinade as well.

A popular celebration of Latin music and dance, Hot Latin Nights was canceled in March 2020 due to the COVID-19 Pandemic.

"Miller's is excited to welcome Hot Latin Nights back to our dance floor," says Bruce McCullough, owner and manager at Miller's Crossing.

"The people loved it, and continue to ask for its return, so that's what we're doing. We're going to bring it back bigger and better than before," McCullough states.

Latin DJ Cesar Urquilla will be spinning tunes at the monthly event.

# Law to Boost Housing Construction Overturned by Montana Supreme Court

The Montana Supreme Court has overturned a lower court order temporarily suspending two pro-construction housing laws passed by the 2023 Montana Legislature, ruling Tuesday that the laws can take effect as a challenge brought by a Bozeman-based homeowners coalition is litigated.

The homeowners, organized as Montanans Against Irresponsible Densification, or MAID, challenged the bills and two other housing measures last year, arguing the Legislature’s efforts to promote infill development by limiting local zoning restrictions amounted to imposing “top-down ‘densification’” that would harm the quality of life they can enjoy in their neighborhoods.

While an initial ruling by Gallatin County District Court Judge Mike Salvagni agreed that the plaintiffs were threatened with immediate harm sufficient to justify blocking the laws while the case is fully litigated, a five-member panel of Supreme Court justices disagreed in a unanimous opinion published recently.

MAID, wrote Justice Beth Baker, “offered only generalized fears and supposition about the potential effects” of the two bills. She also noted that briefs filed by the Montana Legislature and the housing advocacy group Shelter Whitefish had demonstrated that the bills had been passed “to advance the public welfare by addressing the housing crisis” following an “extensive deliberative process” that included the formulation of recommendations by Gov. Greg Gianforte’s housing task force.

MAID members have argued that development made possible under the slate of 2023 housing bills won’t make a meaningful contribution to solving Montana’s housing crisis, which has seen the state’s typical home price, \$470,000 as of July, rise by 64% since the start of 2020, according to real estate website Zillow.

The first of the two previously blocked laws is Senate Bill 323, which would require cities with 5,000 residents or more to allow duplex housing on any home lot. The second is Senate Bill 528, which would require cities to adopt regulations allowing more construction of accessory dwelling units, or secondary housing structures that share parcels with larger homes.

### Montana Has Been Dealing with Gun Legislation for 160 Years!

Montana's first territorial legislature met from December 12, 1864, to February 9, 1865. They passed almost 100 bills

The Daily Montanan featured a June 28, 2021 article by Tim Lehman. It reads in part ‘...According to the territory’s first newspaper editor Thomas Dimsdale, “shooting, dueling, and outrage were daily occurrences” in Virginia City and Bannack. Granville Stuart, as close to a founding father as the territory produced, remarked that in 1860s Virginia City it “became the custom to go armed all the time”.

Yet the territory’s first legislature passed a law banning “the carrying of concealed deadly weapons” anywhere within the limits of any town in the territory. Such laws were not unique to Montana. Most states banned concealed weapons in the 19th century, considering them the weapons of assassins and thieves, not appropriate for an honest man...’

Page 20 of the February 21, 2008 issue of the Carbon County News printed the following from the February 27, 1918 issue of the paper:

Owners of weapons must register them

Every Montana resident who owns a rifle, shotgun revolver, dagger or sword must register his weapon with the sheriff of the county in which he lives under the provisions of the Stevens law enacted at the special session of the legislature.

In addition, every merchant who sells such a weapon must make a record of the transaction for submission to the city officials and no person may purchase a firearm and have it shipped into the state without first obtaining a permit for the transaction.

Sheriff George Headington is already making preparations for the registration of weapons and the issuance of permits and will announce in a few days when and with whom owners of weapons may register. Sheriff Headington desires to emphasize the point that the registration of a weapon is not a permit to carry a concealed weapon.

In a newspaper of that era, an ad from a sheriff emphasizes that all ammunition must be picked up at the sheriff’s office.





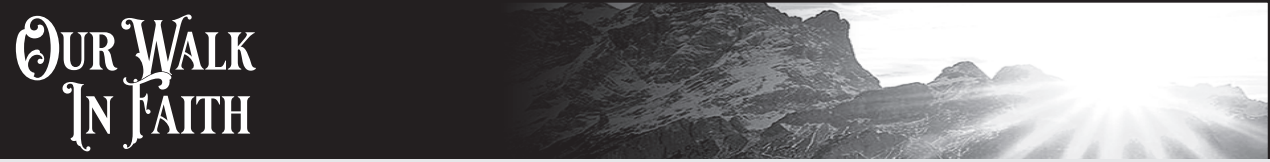

## Forest Service Plans Prescribed Burns in Broadwater County

Recent rains have moderated fire potential on the Helena-Lewis and Clark National Forest and staff will soon resume work to reduce excess fuels across the forest using prescribed fire. We have identified three potential units to burn this week: American Bar, Spruce Hills and Wakina Sky.  
“Prescribed fire is one of our best ways to improve forest health and reduce wildfire severity when paired with other management methods,” said Helena Fire Management Officer Mike Kaiser. “This work is critical to continue to give ourselves more management options for wildfires in the future.”  
Conditions permitting September 25, fire personnel burned 266 acres in American Bar, east of Holter

Reservoir near the Gates of the Mountains. On Thursday, September 26 crews may burn approximately 275 acres in Spruce Hills located east of Canyon Ferry Lake in the Big Belt Mountains. Friday, September 27, we may have a window to burn 205 acres of excess fuels in Wakina Sky, just southwest of Helena.  
During prescribed fire, fire professionals pre-plan, record hourly weather, track smoke dispersal, monitor fire behavior and may cease operations to mitigate wildfire smoke. All prescribed burns are coordinated with our partner Montana Department of Environmental Quality to minimize the harmful impacts of smoke on the community.

Broadwater County Farm Bureau members met at their annual meeting and potluck on Sunday, September 22, at the Lodge in Townsend. Plans were discussed to host a candidate forum in October. All county and state candidates will be invited. Speakers from the Secretary of State's office will be invited to explain various initiatives on the ballot. Dr. Katie Rein DVM introduced members to the survey Crazy Mountain Veterinary Clinic and the Extension Service are conducting regarding antibiotic administration to livestock. New regulations require a veterinarian's prescription for livestock owners to obtain antibiotics to treat their animals. The survey results will give veterinarians some guidance about what antibiotics livestock owners have been using previously in Montana. All answers to the survey are anonymous. Several members completed the survey at the meeting. Livestock owners wishing to participate in the survey can find it online, or contact the Extension office for information.

Jim Willis, of Wilsall, gave a short presentation on the work of the four-county District 10, which includes Broadwater County. Cyndi Johnson, state president of Montana Farm Bureau updated members on the work of the property tax reform committee, and the land classification advisory committee. These items will be addressed by various bills in the upcoming legislature.  
President Gail Vennes reviewed the work of the past year. Two college scholarships were awarded to graduating seniors, Jacob Pesicka and Emily Bird. Farm Bureau hosted the water barrel at the fair.  
New officers were elected for the coming year: Chuck Plymale, president; Virgil Henke, vice president; Carole Plymale, secretary-treasurer. David Plymale was elected a new member of the Board of Directors.  
There are over 150 voting members in Broadwater Farm Bureau. They are kept up to date on issues that affect farming and ranching throughout the year. Members adopt positions on potential legislative issues at the annual meeting, and then they are voted on in November at the annual statewide meeting. Broadwater County sent three resolutions for consideration at the state meeting, all involving concerns regarding groundwater supply and residential subdivisions.

Have you ever gone on a hike or camping trip with your dog and he returns covered in burs? Even though we have several plants with burs in Montana, a likely culprit is houndstongue, also known as beggar's lice. It's a Montana Noxious Weed and very prevalent throughout the county, especially in the mountains.

Description & Habitat

Houndstongue is native to Europe and was introduced to North America as an impurity in a cereal grain shipment. It has been reported in at least 41 Montana counties and is listed as a noxious weed in seven western states. It can be found in rangeland, pastures, roadsides, woodlands and distributed areas.

Houndstongue is a biennial (life cycle of two years). The first and second-year growth look vastly different. During the first year it forms a low growing rosette with large leaves that have fine white hairs and veins like a dog's tongue. The second year it produces a stem, flower and seeds. The stem can reach up to four feet tall and flowers are small reddish-purple. The seeds are pear-shaped and covered with barbs. The plant reproduces solely by seed which can hitch a ride on pets, clothing, livestock and wildlife.

Houndstongue contains alkaloids that are toxic to animals. However, the plants are not very palatable and livestock generally avoid them. There is a greater risk to houndstone poisoning in contaminated hay. It can also displace desirable plants reducing forage quality and quantity and decreasing biodiversity. The burs can

become entangled in wool or livestock hair reducing wool quality. Burs can even become lodged in the eyelashes of livestock causing eye damage.

Management

You can play a role in reducing the spread of seeds, especially with houndstongue. Do not drive or walk in heavily infested areas if possible. Before you leave an infested area, pick all seeds from your clothing, pet or horse and throw them away. Wash vehicles, ATVs and equipment before going home. Purchase only certified noxious weed seed-free hay.

Houndstongue can be dug or pulled if conditions are right. It has a deep taproot that makes it difficult. You can collect plants with seeds and burn them. Seeds on a standing plant will stay viable for 2 to 3 years. Seeds in the ground will only stay viable for one year. Fall burning may destroy seeds. However, fire can also create the ideal situation and disturbance for houndstongue to thrive. Mowing is generally not effective. Grazing will contribute to the spread of houndstongue.

There are currently no approved biological control agents in the United States, because of negative effects on native plant species in the same family.


Because of its extensive taproot, herbicides are a good option for houndstongue. The best strategy is to spray plants during the first year. You can spray first-year plants well into the fall. You need to catch second-year plants in the spring or early summer before seeds mature. Commonly used chemicals include 2-4 D, Banvel, Cimarron, Escort, Telar or Tordon (restricted use). The fuzzy leaf can make herbicide penetration a challenge, so a surfactant is recommended. Always read and follow the entire label when applying herbicide. Common chemical names are used for clarity but does not imply endorsement of a product or brand.

These strategies will help me to prepare for the first Trigonometry exam on Tuesday the 24th. On the same day, I have a Biology exam. So far I have been being drilled on macromolecules and basic chemistry and how it relates to the transfer of energy within the biosphere. Luckily, I learned most of this from Mr. Thomas back at BHS, so the information hasn't been difficult to take in. However, Professor Smith has provided us with countless practice problems for us to utilize in preparation for the exam which I use repeatedly.

School will consume 80% of each semester, and any other time will consume 20%. Many students are on the hunt for the perfect college, trade school, or job. Some are eager to simply get out and be free, some eager to start a life of their own, and some are eager to learn. It looks easy from the outside looking in, but what you are told is not always what it seems. The ratio of schoolwork to free time is 90:10 or even 98:2 and the learning grind never ends. There will be time for fun, but college is for learning. Take advantage of the learning aids provided to you and never give up on all of the work handed to you. It will all be worth it in the end.

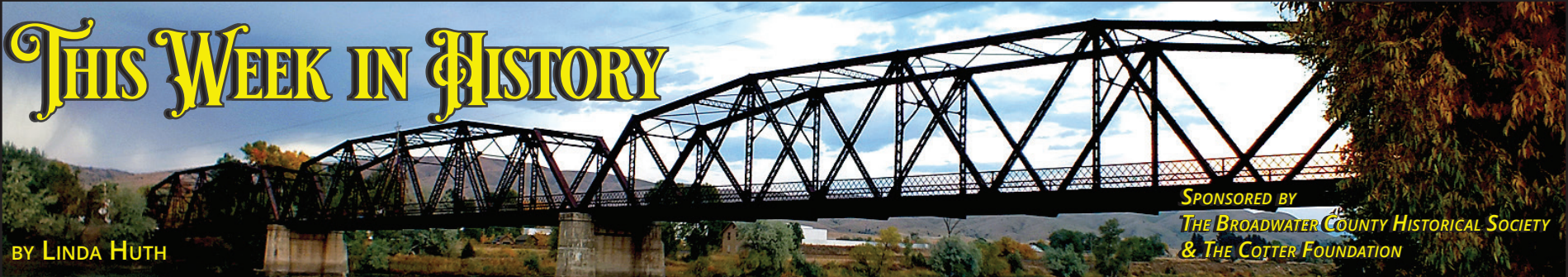

## Big Sky Culinary Dinner was Excellent

On September 20, local Chef Heather Hatwan (owner of Big Sky Culinary Classes) held the second of four planned gourmet dinners at The Lodge of Townsend. Chef Hatwan: "Big Sky Culinary Classes & The Lodge of Townsend are pairing up once again, to initiate an elevated, fine dining experience IN Townsend!

We all know there is a need and desire for a different fare, a high-quality food establishment that we can enjoy without having to drive to another town, here in Townsend.

Together we are collaborating to create a restaurant-type environment that feels, looks, tastes and exemplifies the styles we drive miles to experience.

Heather Hatwan & Tina Homann believe bringing to Townsend what we (and your expressed interest) ourselves would like to enjoy & would benefit the community immensely. Our idea is to have 3-course dinners, 4 times a year with a full kitchen staff and wait staff. This concept would be a "Reservation Only" dinner to help us prepare efficiently to provide you with the service and meal you deserve. The menus will be carefully curated using the freshest of local ingredients including vegetables, grains and meats.

The dinner was a 3-course meal featuring a Southern-style salad, Shrimp and Scallops over a saffron polenta, followed by a dessert of bread pudding with a rum sauce.

The Southern-style salad featured sweet potato slices along with a fresh greens mix and was delicious. The shrimp and scallops were served in a delicate red sauce served over saffron polenta. I love polenta but in the past I have found that I do not like saffron; but Chef Hatwan served her saffron polenta with a delicate touch and the polenta was excellent. The shrimp and scallops were cooked perfectly! Afterwards, we were served a generous portion of bread pudding with a rum sauce that was very good.

Our servers were Chrissy Rouse and Kara Campbell. They seated us and served our meal. They were delightful and made us feel welcome and well-cared for.
